A thirty day public-examination and comment period will begin on Thursday, February 23, 2017 and end on March 27, 2017. The FY 17-18 Action Plan is the third annual implementation plan under the State of Connecticut 2015-2019 Consolidated Plan for Housing and Community Development (ConPlan). The ConPlan is a five-year strategic plan that governs the administration of federal funding appropriated for housing and community development activities that benefit persons of low- and moderate- income. Such federal funding includes the National Housing Trust Fund, the HOME Investment Partnerships (HOME), Small Cities/Community Development Block Grant (SC/CDBG), Emergency Solutions Grants (ESG), and Housing Opportunities for Persons with AIDS (HOPWA). The State of Connecticut will describe its plan for the implementation of the new National Housing Trust Fund, which is anticipated to provide up to \$3,000,000 in the next fiscal year. The FY 17-18 Action Plan represents approximately \$24M in federal funding for those five programs. A Public Hearing will be held, as listed below, to solicit comment on the DRAFT FY 17-18 Action Plan for Housing and Community Development. Additionally, input on performance under the aforementioned programs is also welcomed.
