Executive Summary:

Connecticut's resilience activities exist at three scales: local demonstration infrastructure projects that will enhance resilience in the low-moderate income City of Bridgeport as a model for the rest of the state, a regional planning process to create a blueprint for resilience across the MID-URN areas of Fairfield and New Haven Counties, and state policy to institutionalize resilience through the SAFR (State Agencies Fostering Resilience) Council.

In Bridgeport, NDR funds will be used to construct three projects and complete two studies. The state will construct a raised University Avenue to provide dry egress for multiple properties that are receiving state support to remediate brownfields and redevelop as mixed-use, a berm that will encircle the eastern area of the South End and significantly reduce flood risk to a large area that includes power generation and substations as well as affordable and historic housing and future transit-oriented development opportunities, and a resilience design center to act as a community hub for resilience activities. The state will study the potential to leverage the regional energy generation and distribution infrastructure located in the South End of Bridgeport for neighborhood benefit and the opportunities for redevelopment in the flood plain in a responsible and resilient manner.

Across Fairfield and New Haven Counties, NDR funds will be used to develop the regional coastal resilience plan, Connecticut Connections. This plan will be based on modeling to be conducted to better understand flood risk and the combination of coastal surge and riverine flooding and provide a blueprint towards resilience for the communities from Greenwich to Madison.

Statewide, NDR funds will support the SAFR Council in their effort to create a resilience roadmap for the state and to institutionalize resilience into state policies.

The activities being carried out under NDR contribute to the State's efforts to affirmatively further fair housing by: 1) enabling the continued safe habitation of existing affordable housing opportunities within walking distance of jobs, public transportation and amenities; 2) mitigating both present and future flood related issues of both publicly and privately owned properties targeted for future multifamily and economic development; and 3) preserving and increasing the potential for affordable homeownership opportunities in this target neighborhood. In addition, the NDR activities will contribute to addressing the regional need to affirmatively further fair housing by encouraging both housing and economic development in low flood risk and transit-oriented neighborhoods across Fairfield and New Haven counties. Many of these NDR activities address specific action steps found in the State of Connecticut Analysis of Impediments to Fair Housing Choice, which is compliant with and supports the federal obligation to affirmatively further fair housing. These action steps include: 1) encourage the creation and rehabilitation of affordable housing in a variety of locations; 2) collaborate with other state agencies to affirmative further fair housing; and 3) ensure state and local planning documents affirmatively further fair housing.

MID-URN Areas:

The State of Connecticut activities focus on the MID-URN geographies of Fairfield and New Haven Counties with the NDR-funded infrastructure activities limited to the Low-Mod income city of Bridgeport.

Key Agencies, Partners, Positions, Personnel:

Staff at the Department of Housing will oversee all activities funded through the NDR grant. In addition to a Director of the program, the state will be competitively procuring program management support for grant management, compliance, finance, and other functions. The bulk of the work will be conducted by consultants and the state is just completing its first public procurement for alternatives assessment, environmental review, and preliminary engineering. Additional consultants will be procured as needed as the projects progress. The CT Institute for Resilience and Climate Adaptation (CIRCA) at the University of Connecticut will act a sub-recipient, leading the CT Coastal Connections Regional Plan process.



Other state agencies through the SAFR Council including the Office of Policy and Management, Department of Transportation, Department of Energy and Environmental Protection and others will support the Department of Housing on timely permitting, review, and other support measures to ensure that the outcomes and timelines of the projects are met.

Overall Progress Narrative:

The third quarter of 2019 focused on responding to public comment received on the Draft EIS, completing the Final EIS (FEIS), and drafting the Programmatic Agreement (PA) including mitigation measures to resolve adverse effects to historic properties as part of Section 106 of the National Historic Preservation Act with the CT State Historic Preservation Office. The FEIS included a Preferred Alternative for the Proposed Action based on comments received on the Draft EIS. The FEIS and a copy of the draft Final PA were posted for a 30-day public comment period with a Notice of Availability posted in the Federal Register on September 6, 2019. During the public comment period in September the CT DOH held teleconferences with consulting parties to review the draft Final PA. A teleconference was held with the Technical Advisory Committee on September 23, 2019 to review the Preferred Alternative of the FEIS and draft Final PA.

For Administration, the CT DOH responded to questions from HUD headquarters during a monitoring visit in July and implemented improved record-keeping protocols. The project management consultant team continues to support all aspects of administration including procurement, finance, audit, monitoring, document storage, environmental review, and construction.

The third quarter of 2019 was highlighted by ongoing work to complete the Final EIS, most notably the drafting and finalizing of the Programmatic Agreement (PA) between CT DOH and CT SHPO and posting of the Notice of Availability of the FEIS and draft final PA on September 6, 2019 beginning a 30-day public comment period. In response to public comments, the FEIS included a Preferred Alternative 1 and three additional alternatives for the alignment of the coastal flood defense system and evaluated them for their environmental impacts. The four alternatives were in place of the Eastern and Western alignments with a shaded area between them in the Draft EIS. The Preferred Alternative 1 alignment in the FEIS offered the greatest area of flood protection and avoided an adverse impact to the historic Cottage district in the South End. The draft Final PA included mitigation measures for the adverse effect on Seaside Park where the coastal flood defense system crosses the entrance to the park between Broad and Main streets. The mitigation measures included an update to the Seaside Park national register nomination, two additional nominations in the Bridgeport area related to the Olmsted firms, a Seaside Park preservation and implementation plan with implementation funds and replacing trees impacted during construction in the park. CT DOH met with consulting parties to review these mitigation measures during the public comment period.

The draft Resilient Connecticut Planning Framework was reviewed with the SAFR Council State Agency Workgroup at meetings on July 15th and September 9th Comments were incorporated into a 2nd draft Framework. A CIRCA-lead Technical Feedback Listening Session was held at Avery Point on September 5th to gather additional input from planning and engineering consultants with experience in resilience project planning and implementation in Connecticut and the region. A final Draft Resilient Connecticut Planning Framework was completed for review by CT DOH. A meeting with CT Department of Transportation, CT DEEP, and CIRCA was held on September 25th to further discuss road flooding issues as well as, opportunities to align DOT planning with the Regional planning phase (Phase II) of Resilient Connecticut. A meeting with the CT Department of Homeland Security and Emergency Management (DEMHS) was also held on September 25th to discuss the role of DEMHS Regional Emergency Management Planning Teams in coordinating across towns and regions and opportunities for collaboration. CIRCA began development of an RFQ to solicit contractors for the Phase II regional analysis and engagement, and Phase III pilot project development and implementation planning work.

This quarter the Resilient Connecticut Team's technical support activities team focused on developing the numerical modeling capability, improving the vulnerability mapping, initiating fieldwork and continuing the development of capacity building activities. CIRCA focused on numerical model domain development by generating topography, and bathymetry data for the Long Island Sound obtained from LIDAR data with the NAVD88 datum. Water levels simulated for Bridgeport, New Haven, New London, and Montauk tide stations are being calibrated to match model results for Hurricane Sandy in order to verify the representation of the Long Island Sound in CIRCA's numerical model. The input biophysical and socio-economic variable analysis has been completed for CIRCA's initial coastal vulnerability assessment. The resulting seven exposure layers have been prepared considering coastal exposure, physical impact, saltwater intrusion impact, natural habitat, critical facilities, and social vulnerability. Planning for initial fieldwork sites has been completed. A set of pressure and acoustic doppler sensors are planned to be deployed for upstream and downstream of six initial locations in Fairfield and New Haven Counties. The first annual Resilient Connecticut Summit was scheduled and registration was announced. CIRCA's monthly webinar series continued in this quarter with a session in July on "New Planning and Visualization Tools for Sea Level Rise" and September on "Connecticut's climate report: precipitation projections and a New Haven case study."
